#### **OUR SCHOOL COMMUNITY**

USD 209 Moscow is located in southwest Kansas with most of our district in northeast Stevens County. The district also extends into smaller portions of Grant and Seward Counties. The size of the district is 223 square miles.

The community espouses classic Midwestern values while enjoying a climate more in line with the Southwestern United States. The winters are mild, the summers are warm, humidity is low, and the sunsets are breathtaking.

Mileage to excellent shopping and entertainment: 32 miles to Liberal, 55 miles to Garden City, and 70 miles to Dodge City.

Driving time to major cities: 2.5 hours to Amarillo, Texas, 3.5 hours to Wichita, Kansas, and 5 hours to Denver, Colorado.

Community support and pride in school district--In the summer of 2015 we had a mail ballot election to keep our local option budget at 33% and it passed with 126 yes votes to 7 no votes (95% in favor).

Well-established partnerships and collaboration with the City of Moscow and the Recreation Commission including shared use of excellent facilities, ball fields, and swimming pool.
