OUR COOP COMMUNITY

ANW Cooperative was organized on September 9th, 1971. Our first year of operation was 1972 and we serviced 155 students. Today we serve 1,000 to 1,500 students in any given year, and our services are provided to students ranging from Gifted to Severely Multiply Handicapped.

We deliver special education services in our eightmember school districts, encompassing over 30 school buildings in a five-county area in Southeast Kansas, in the counties of Allen, Anderson, Neosho, Wilson, and Woodson. Our 8 member districts are:

Any student of preschool age, 3-5 years, through age 21, who is developmentally delayed, handicapped or those with special needs and can meet the eligibility requirements determined by a comprehensive evaluation are eligible for services based on local, state, and federal guidelines and regulations.

All services provided by ANW Education Cooperative are available at no cost to parents whose children meet eligibility requirements.
